**ON THE ANNOUNCEMENT OF THE MEMORIAL COMPLEX WITH A SPECIAL
NATIONAL INTEREST "ADEM JASHARI" IN PREKAZ**

Assembly of Kosovo,

Based on UNMIK Regulation no. 2001/9, date May 15, 2001 for the Constitutional Framework on Provisional Self-governing in Kosovo, Chapters 5.1 (g), and (p),

Considering the inevitability of protecting the Memorial Complex "Adem Jashari" in Prekaz as an area with special national interest which has an ontological, anthropological, historical, and cultural significance for Kosovo citizens,

Approves :

**LAW ON THE ANNOUNCEMENT OF THE MEMORIAL COMPLEX WITH A SPECIAL
NATIONAL INTEREST "ADEM JASHARI" IN PREKAZ**

Section 1

This law defines the status of the Memorial Complex "Adem Jashari" in Prekaz, its maintenance, protection from political influences and obligations of Kosovo's institutions towards it.

Section 2

The Memorial Complex "Adem Jashari" is announced an area with a special national interest for Kosovo and is put under the protection of Kosovo's institutions.

Section 3

The Memorial Complex “Adem Jashari” in Prekaz has an ontological, anthropological, historical and cultural and civic significance for Serbica/Skenderaj Municipality, Drenica, Kosovo and the wide Albanian nation.

Section 4

4.1.The Memorial Complex “Adem Jashari” covers the area of the graves of national martyrs, where bodies of the members Jashari family rest, the location inhabited by the family, the Jasharaj neighbourhood and the other area they used for armed resistance aiming to protect their dignity and defend Kosovo.

4.2.The total area and surface covered by the Memorial Complex “Adem Jashari” will be determined by the Urban Plan of Serbica/Skenderaj Municipal Assembly.

Section 5

Kosovo institutions and municipal authority bodies will oversee and maintain the memorial Complex “Adem Jashari” in Prekaz.

Section 6

Oversight and maintenance expenditures for the Memorial Complex “Adem Jashari” will be covered by KCB.

Section 7

The Government of Kosovo will provide financial means for the construction of the Memorial Complex “Adem Jashari” in Prekaz.

Section 8

Any political party action, rally or other political manifestation within the area of the Memorial Complex “Adem Jashari” is forbidden.

Section 9

The present law shall enter into force after adoption by the Assembly of Kosova on the date of its promulgation by the Special Representative of the Secretary-General .
