STATEMENT OF COMPLIANCE OF LEGISLATION OF THE REPUBLIC OF  
KOSOVO WITH THE EU ACQUIS

1. Proposing body of the normative act: Ministry of Justice.
2. Title of the project normative act: Draft Law on amending and supplementing of Law No. 08/L-013 on Property Rights of Foreign Citizens in the Republic of Kosovo.
3. Compliance of the normative act with the provisions of the Association Stabilization Agreement or the Temporary Agreement.

ARTICLE 83

Strengthening institutions and the rule of law

Regarding their cooperation in the field of freedom, security and justice, the Parties will pay special attention to the consolidation of the rule of law, and the strengthening of institutions at all levels in the field of administration in general and the administration of law enforcement, and administration of justice in particular. The cooperation specifically aims at strengthening the independence, impartiality and accountability of the judiciary in Kosovo and improving its efficiency, developing appropriate structures for the police, prosecutors and judges and other judicial and law enforcement bodies to prepare them adequately, for cooperation in civil, commercial and criminal matters, and to enable them to effectively prevent, investigate, prosecute and judge organized crime, corruption and terrorism.

3.2 The time frame determined for the approximation and harmonization of the legislation in accordance with the provisions of the MSA and the Interim Agreement.

#### ARTICLE 74

1. The parties recognize the importance of aligning the existing legislation of Kosovo with that of the EU and its effective implementation. Kosovo will endeavor to ensure that its existing laws and future legislation gradually move towards compliance with the EU acquis. Kosovo will ensure that existing laws and future legislation will be properly implemented and enforced.

2. This alignment shall begin on the date of signature of this Agreement, and shall extend gradually in all elements of the EU acquis referred to in this Agreement until the end of the transitional period defined in Article 9.

#### ARTICLE 9

The progressive and full association will be realized over a period of ten years.
